TRANSITION RESOURCE ACTION CENTER (TRAC) PROVIDES A "ONE STOP" ASSESSMENT/INTAKE AND REFERRAL FACILITY FOR TRANSITIONAL LIVING SERVICES FOR YOUTH EXITING FOSTER AND JUVENILE CARE IN NORTH TEXAS. TRAC BRINGS TOGETHER COMMUNITY RESOURCES AND INTENSIVE CASE MANAGEMENT SERVICE. IT IS THE ONLY SUCH PROGRAM IN NORTH TEXAS THAT EXISTS TO COMPREHENSIVELY ADDRESS THE NEEDS OF THIS POPULATION. TRAC IS THE REGIONAL SAFETY NET FOR FORMER FOSTER YOUTH ONCE THEY ARE ON THEIR OWN. ANNUALLY, TRAC HELPS OVER 750 OF THE MOST CHALLENGED AT-RISK TEENS MAKE A LIFE PLAN AND ACQUIRE SKILLS THEY NEED TO SURVIVE ON THEIR OWN AFTER THEY TURN AGE 18.

IN 2015, THE PROGRAMS DELIVERED APPROXIMATELY 750,000 MEALS TO 15,000 CHILDREN AT 200 LOCATIONS. DURING 2015, THE FOOD PANTRY DISTRIBUTED 1,022,523 POUNDS OF FOOD TO 6,162 HOUSEHOLDS, WHICH WERE COMPRISED OF 15,944 UNDUPLICATED INDIVIDUALS.
